

Ignited Academia – Easter Intensive Revision Course Terms & Conditions

1. Course Structure

The Easter Biology Intensive is a one-off revision course delivered once a year through a series of live online sessions.

The course includes:

- Live online teaching sessions
- Access to the Biology Resource Library via Google Classroom
- Supporting course materials

Students are expected to attend the scheduled sessions for the cohort they have enrolled in.

2. Access to Course Materials

Students receive access to the Biology Resource Library, which includes:

- Video lessons covering key syllabus topics
- Revision materials and notes
- Practice resources and quizzes

Access to the resource library is provided for three months from the date of enrolment, regardless of whether the student chooses the pay-in-full option or the instalment payment plan.

Access is for personal use only and does **not transfer ownership** of any materials. **Copying, or sharing materials is strictly prohibited.** Breach of this condition may result in immediate removal from the course without refund.

3. Attendance

- Students are expected to attend sessions at the scheduled time.
- Sessions cannot be rescheduled for individual students.

- Recordings of live sessions are not provided.
- Students may use the resource library video lessons as a substitute if a session is missed.
- No refunds are issued for missed sessions.

4. Payment Policy

- A place on the course is secured once payment has been made, either through the pay-in-full option or the instalment payment plan.
- Spaces are limited and allocated on a first-come, first-served basis.

For instalment plans:

- All scheduled payments must be completed according to the agreed schedule. Payments will be automatically debited from the student's account on the same day of each month.
- If a scheduled payment is not received within **5 days** of the due date, the student's access to the course and materials may be suspended or removed until the payment is received.
- Failure to complete payments may result in immediate removal from the course and revocation of access to all materials.
- **The remaining balance of the course will still be due and payable even if access has been removed.**

5. Cancellation & Refund Policy

Full Refund:

- Students may request a full refund **until 11:59pm (UK time) on the first day of the course.**
- Refund requests must be made by email.
- Access to all course materials and the resource library will be immediately revoked upon processing of a full refund.

- Optional membership/library fees (£25/month) are not included in refunds; students may continue access by paying the standard membership fee.

Partial (Pro-Rata) Refund:

- After the first day of the course, partial refunds may be considered for **remaining sessions not yet attended**, calculated on a pro-rata basis:
Refund = Total course fee / Total sessions × Number of remaining sessions

- Refund requests must be submitted **by email the evening before the next session begins OR by 11:59pm (UK time) on the day the student decides to withdraw.**

Material Protection & Partial Refund Adjustment:

- Access to course materials does **not transfer ownership**. Copying or sharing course materials in any form is strictly prohibited.
- Ignited Academia reserves the right to adjust any partial refund if course materials have been accessed beyond standard usage (e.g., large-scale downloading or redistribution), to reflect partial usage.

Instalment Plan Considerations:

- Students enrolled on an instalment plan remain liable for all scheduled payments until a refund is processed.
- Partial refunds after the first day of the course will be calculated on a pro-rata basis for sessions **not yet delivered**.
- Any refund will be applied against the total course fee already paid. If the student has paid more than the value of sessions attended, the difference will be refunded.
- If the student has paid less than the value of sessions attended, they remain liable for the remaining balance according to the agreed instalment schedule.

No Refunds Will Be Issued For:

- Missed sessions
- Scheduling conflicts
- Change of mind after the refund deadline
- Any optional membership/library fees

6. Behaviour & Engagement

- Students are expected to behave respectfully during live sessions and contribute to a positive learning environment.
- The tutor reserves the right to remove any student whose behaviour disrupts the class. In such cases, no refund will be issued.

7. Intellectual Property

- All teaching materials, videos, slides, notes, and resources remain the property of Ignited Academia.
- These materials may not be copied, redistributed, shared outside the student's household, or resold
- Breach of this condition may result in immediate removal from the course without refund.

8. Tutor Cancellation

In the unlikely event that a session must be cancelled due to unforeseen circumstances, an alternative session or appropriate replacement content will be provided.

9. Agreement
